## **CCL National Call video clip**

Mark Reynolds proudly introduced the new staff who were added to support the big push by CCL for carbon pricing in legislation currently being drafted. HR 2307 now has 49 cosponsors. Discussion of the new "Airmeet" format for the June CCL Conference (12-13<sup>th</sup>, virtual), which they feel will "mimic an in-person event much better." Can move from session to session, there's a lounge for networking, virtual tables, etc.

Reynolds requested that chapters consider taking actions including "nurture your people" and "reach out to your mayors." He shared his excitement about last month's very high numbers of LTEs (304) Op-eds (123) and a stunning 9K letters to members of Congress (vs. normal 3K!)

## CCL Tacoma Workflow Overview (2020-21)—Barbara Menne

Our chapter seeks to empower everyday people and help them learn new skills in order to build political will for a national bipartisan solution to climate change.

Our major activities around the year:

#### Fall

Pierce County Council candidate interviews at meetings (election results- added a new environmentally friendly member, Jani Hitchens)

Various get-out-the-vote efforts (pursued individually)

CCL December conference and lobbying meeting

#### Winter

Jan-April focus on WA state legislative session, commenting and testifying on proposed legislation (much of which passed!)

CCL March lobby meetings (with Kilmer, Strickland, and others)

Energy Innovation and Carbon Dividend Act was reintroduced as HR2307

### **Spring & Summer**

Ongoing focus on local issues and legislation such as the Pierce County Sustainability Plan (passed!), stopping fossil fuel permits at the Tideflats, and encouraging the Pierce County Regional Council to be a center for climate collaboration with small cities and towns.

Tabling can start in person again, Tacoma Ocean Fest coming June 6 and Steilacoom EV event on September 11

**S--Saves lives--**1 in 10 US deaths are caused by pollution, especially in people of color and frontline communities
