## THE BIG NEWS: HR 7173 ENERGY INNOVATION AND CARBON DIVIDEND ACT

Sponsored by Rep Ted Deutch (D - FL) and now also has 3 republicans and 3 democrats as co-sponsors.

The bill has dropped, this is carbon fee and dividend. Deliberately dropped in the lame duck session to start gathering support for when it is reintroduced in the 2019 session.

How it works, from the CCL Community website:

- 1. Carbon Fee: This policy puts a fee on fossil fuels like coal, oil, and gas as far upstream as possible. It starts at \$15/ton and increases by at least \$10/ton annually. This will drive down carbon pollution because energy companies, leading industries, and American consumers will move toward cleaner, cheaper options.
- Carbon Dividend: The money collected from the carbon fee is allocated in equal shares every month to the American people to spend as they see fit. Program administrative costs are paid from the fees collected. The government does not keep any of the money from the carbon fee.
- 3. Border Carbon Adjustment: To protect the US manufacturers and jobs, imported goods will pay a border carbon adjustment, and goods exported from the US will receive a refund under this policy.
- 4. Regulatory Adjustment: This policy prevents additional regulations on covered CO2 emissions, as long as emission targets are being met. If emission targets are not met after 10 years, then EPA regulatory authority over these emissions would be restored. Regulations based on other pollutants will not be affected, nor will regulations such as auto mileage standards, water quality and more. The Clean Air Act is still in effect.
